- Complete the **2023-2024 FAFSA** and be enrolled in at least 5 credits per semester
- **If first-time borrower, complete the GradPLUS MPN (loan agreement) & the mandatory Entrance Loan Counseling at <https://studentaid.gov> for approved loans to disburse. You will need your FSA User ID and PIN to "Sign In" and be sure to select Complete Aid Process, then select "Graduate PLUS MPN" then select "Complete Entrance Counseling".**

Example: (Loan amount desired (\$5,000) ÷ by disbursement fee (.95772) = loan amount to request (\$5,221) in whole numbers. **Please note a new disbursement fee will be in effect Oct 1, 2023–Sept 30, 2024.**
